House Raffle Rules  
Effective April 26, 2022

- ❖ Purchase of a raffle ticket constitutes an individual's consent to these house raffle rules.
- ❖ Cost of each raffle ticket is \$10, paid by cash or check payable to St. Thecla Parish. Tickets must be paid in full at the time of purchase.
- ❖ Tickets will be sold only to individuals 18 years of age or older at the time of purchase.
- ❖ The individual whose name appears on the ticket is the entrant and owner of the ticket.
- ❖ Tickets are non-refundable and non-transferrable.
- ❖ There is no limit on the number of times a person may enter the raffle.
- ❖ The ticket selling period begins at 12:01 am on April 26, 2022 and ends at 5:00 pm Eastern Time on September 18, 2022.
- ❖ The parish assumes no responsibility for late, damaged, incomplete, or illegible entries.
- ❖ Winners need not be present to win.
- ❖ Taxes are the sole responsibility of the winners. All qualifying raffle ticket winnings will be reported on Form W-2G. The parish will report, withhold and remit to taxing authorities amounts from prizes as required by applicable federal, state and local law.
- ❖ The Grand Raffle drawing will be held on the parish grounds on Sunday, September 18, 2022 at 6:00pm. In the event the raffle drawing cannot be conducted as scheduled, the drawing will occur at the parish on Monday September 19, 2022 at 6:00pm.
- ❖ Winners will be determined by random drawing. The first ticket drawn wins first prize, the second ticket drawn wins second prize, and so on. The winner is the individual whose name appears on the ticket.
- ❖ Winners will be notified by telephone the day after the drawing. The parish will not be responsible, nor have any liability for unsuccessful efforts to notify a winner.
- ❖ Any prize not claimed, or for which a winner cannot be located within sixty days from the date of the drawing shall, at the discretion of the parish, be distributed in accordance with one of the following methods: 1) the parish will conduct another drawing using the original pool of ticket stubs, or 2) with the prior written approval of the State of Michigan, in accordance with the published rules of the Bureau of State Lottery, the prize(s) shall be donated to the Knights of Columbus Council 12403.
- ❖ Winners must claim their prize in person at the parish office located at 20740 S. Nunneley Road, Clinton Twp., Michigan, during regular office hours (M-Th 8:30-noon, and 1:00-4:00pm; Fri 8:30 - noon). Winners must present a photo ID and their ticket stub and complete the appropriate government form to claim their prize.

❖ Acceptance of a prize shall constitute a winner's consent to the use of their name and/or photograph for advertising and promotional purposes by the parish without further compensation.

### Early Bird Drawings

❖ All house raffle rules apply to the early bird drawings.

❖ For each 10 raffle tickets sold, sellers may enter the Early Bird Drawing. Grand Raffle Ticket stubs and payment should be returned along with a completed Early Bird Ticket (available in the Parish Office).

❖ Drawings will be held at June 12th, 2022 at 3 p.m., and August 27th, 2022 at 6 p.m. on the parish grounds.

❖ Deadline to enter the June 12, 2022 drawing is 12 p.m. June 11, 2022. Once the winning ticket is pulled, the remaining tickets will be automatically entered into the August 27, 2022 drawing.

❖ Deadline to enter the August 27, 2022 drawing is 4:00 pm August 27, 2022.

❖ Winners will be contacted via telephone on the next business day following each drawing.
